3 **Now cometh:** Nicklas Arthur, Surname: a good and lawful Christian man, humble servant of the Most  
4 High, God the Father, Creator of Heaven and Earth, and declares: I do not qualify for State Drivers  
5 License, ID or other travel documents because the State requires first that I voluntarily engage in  
6 business with the Social Security Administration of the U.S. so that I may be numbered by them. I  
7 cannot in good conscience apply for Social Security benefits nor take part in any construct which  
8 requires me to break the commandments of my God and risk the punishment of eternal damnation.

9 **I further declare** that I have repented of any and all past acceptance or entanglement with any such  
10 “mark of the beast” numbering system. Following\* are listed some of the Laws Of My King  
11 Yahushua (a.k.a. Jesus) regarding this matter for your consideration.

12 **I request that** I be allowed to travel and conduct my lawful activities unmolested by any servants of  
13 quasi-governmental agencies or other private entities. I wish to thank you in the Name of King

20 **\*OLD & NEW TESTAMENT LAW PROHIBITING PARTICIPATION IN SOCIAL**  
21 **SECURITY BY CITIZENS OF HIS KINGDOM**

22 **Exo 20:17** Thou shalt not covet thy neighbour's house ...nor any thing that *[is]* thy  
23 neighbour's.

24 **Pro 1:10** My son, if unbelievers entice thee, consent thou not. **(11)** If they say, Come with  
25 us, ... Cast in thy lot among us; let us all have one purse: **(15)** My son, walk not thou in the  
26 way with them; refrain thy foot from their path:

27 **Rom 13:8-10** Owe no man any thing, but to love one another: for he that loveth another hath  
28 fulfilled the law. **(9)** For this, Thou shalt not commit adultery, Thou shalt not kill, Thou shalt  
29 not steal, Thou shalt not bear false witness, Thou shalt not covet; and if *[there be]* any other  
30 commandment, it is briefly comprehended in this saying, namely, Thou shalt love thy  
31 neighbour as thyself. **(10)** Love worketh no ill to his neighbour: therefore love *[is]* the  
32 fulfilling of the law.

33 **2Co 6:14-17** Be ye not unequally yoked together with unbelievers: for what fellowship hath

34 righteous with unrighteousness? and what communion hath light with darkness? (15)  
35 And what concord hath Christ with Belial? or what part hath he that believeth with an infidel?  
36 (16) And what agreement hath the temple of God with idols? for ye are the temple of the  
37 living God; as God hath said, I will dwell in them, and walk in *[them]*; and I will be their God,  
38 and they shall be my people. (17) Wherefore come out from among them, and be ye separate,  
39 saith the Lord, and touch not the unclean *[thing]*; and I will receive you,..  
40 **Mat 10:28** And fear not them which kill the body, but are not able to kill the soul: but rather  
41 fear him [GOD] which is able to destroy both soul and body in hell.  
42 **Rev 14:9-10** ...If any man worship the beast and his image, and receive *[its]* mark in his  
43 forehead, or in his hand, (10) The same shall drink of the wine of the wrath of God...

45 **Section 7 of Pub. Law 93\_579: (a)(1) It shall be unlawful for any Federal, State. Or local**  
46 **governmental agency to deny to any right, benefit, or privilege provided by law because of such**  
47 **individual’s refusal to disclose his social security account number... Whoever, under color of any**  
48 **law, statute, ordinance, regulation, or custom, willfully subjects any person in any State,**  
49 **Territory, or District to the deprivation of any rights, privileges, or immunities secured or**  
50 **protected by the Constitution and laws of the Unites States... shall be fined under this title of**  
51 **imprisoned not more than one year, or both;... 42 USC § further provides that a violators “shall**  
52 **be liable to the party injured in an action at law, suit in equity, or other proper proceeding for**  
53 **redress.”**
